



Dear football players and parents,

It's time to think football. Our **registration fee is \$210 (due at Equipment Issue in August) for all grades**. The fee includes use of the League's protective gear (helmet, shoulder pads, jersey, pants, etc.), a mouth-guard, and photo sports pack (individual and team pictures). Upon equipment issue, each player will receive raffle tickets that sell for \$3.00 each, and the player keeps the money. The raffle drawing will be held at the end of the season. This gives the participant and their family the opportunity to earn back the entire registration fee.

Every participant **to be eligible, must pay the registration fee, provide a copy of a birth certificate for the League's records, and provide a registration form** before or on Equipment Issue Day in August.

Please arrange to have a **copy of the birth certificate** available for League records. **A copy can be mailed with the registration form or brought to our Equipment Issue Day in August.**

The participation in sports involves some risk to its participants. SIYFL, through its uses of specially adapted rules, regulations, and protective equipment, helps to minimize these risks. However, participants and their parents or guardian must accept personal and financial responsibility for the risks associated with these sports. I acknowledge, by signing, that I will provide medical insurance for my child. I also do not hold the League or its directors/officers liable for medical expenses that may occur. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child and I may be exposed to or infected by COVID-19 by attending SIYFL events, activities, camps, sponsored camps, practices, games, or any other SIYFL function and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at SIYFL activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child may experience or incur in connection with my child's attendance at event, activity, camp, sponsored camp, practice, game, or any other SIYFL function ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless SIYFL, its employees, agents, volunteers, trainers, coaches and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of SIYFL, its employees, agents, volunteers, trainers, coaches, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any SIYFL event, activity, camp, sponsored camp, practice, game, or any other SIYFL function.

I understand that the SIYFL permits the participant to use the below mentioned equipment at no charge. I agree to maintain and return the equipment in the same condition as it was issued (except for normal wear and tear). The League reserves the right to determine the status of said equipment. I also agree that in the event any of the below equipment is damaged, not returned, lost, or stolen, that I am held responsible for its replacement cost. I also understand that if the equipment is not returned by Equipment Return Date, I am held responsible for the entire cost of the below issued equipment. I further agree to abide by all SIYFL Bylaws, Game Rules, and Policies.

No refunds will be made after the first day of practice. All fees and birth certificate are due on Equipment Issue Day.

Southwest Idaho Youth Football League 2026 Fact Sheet

Originally formed in 1968 with approximately 6 teams from Pocatello. Not-for-profit organization 501c (3). We are an all-volunteer managed league that is funded thru player registration fees and generous donations from local businesses. As a not-for-profit organization, we are always looking to keep our costs to a minimum for our families of the surrounding communities. We provide equal opportunity for all kids to play, boys and girls.

For 2025, we had 60+ teams from 4th thru 8th grade represented from: Aberdeen, American Falls, Bear Lake, Blackfoot, Chubbuck, Firth, Fort Hall, Grace, Inkom, Malad, Marsh Valley, McCammon, Pocatello, Rockland, Snake River, Soda Springs, Westside, Mini-Cassia Youth and Upper Valley Grid Kid programs.

Total players participated for 2025: approximately 1400.
